**H. B. No. 548**-Representative Pryor. Cosponsor: Representative Book.

To amend section 311.01 of the Revised Code to change the eligibility requirements for county sheriff.

**H. B. No. 549**-Representative Dyer. Cosponsors: Representatives Harris, Murray.

To amend section 4710.01 and to enact sections 4710.20 to 4710.43 of the Revised Code to establish licensing and regulation of debt settlement services.
