# **INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 550**-Representatives Snitchler, Okey. Cosponsors: Representatives Dyer, Stebelton, Blessing, Derickson, Hackett, Letson.

To amend section 1707.20 and to enact section 1707.49 of the Revised Code to specify the form of financial statements and to include administrative assessments and other remedies as a remedy for a violation of the Ohio Securities Act.

H. B. No. 551-Representative Snitchler.

To enact section 743.50 of the Revised Code to require a municipal utility supplying surplus electricity to nonresidents to provide written notice of termination one year before terminating the service.

H. B. No. 552-Representatives Hagan, Gerberry.

Cosponsors: Representatives Dyer, Harwood, Okey, Yuko, Weddington, Murray, Chandler, Harris, Brown, Foley, Bolon, Domenick, Newcomb, Goyal.

To amend section 4511.091 of the Revised Code to prohibit a person from being arrested, charged, or convicted for speeding on a public street, highway, private road, or driveway based on a peace officer's unaided visual estimation of the speed of a motor vehicle, trackless trolley, or streetcar.

H. B. No. 553-Representative Sears.

Cosponsors: Representatives Adams, J., Blessing, Boose, Burke, Grossman, Harwood, Jordan, Maag, Martin, Ruhl, Wachtmann.

To amend section 4511.091 of the Revised Code to prohibit a person from being arrested, charged, or convicted for speeding on a public street, highway, private road, or driveway based on a peace officer's unaided visual estimation of the speed of a motor vehicle, trackless trolley, or streetcar.

# H. B. No. 554-Representative Luckie.

Cosponsors: Representatives Hackett, Domenick, McGregor, Coley, Slesnick, Derickson.

To amend section 121.085 and to enact sections 1322.21 to 1322.38 of the Revised Code to establish the Installment Loan Act.

Said bills were considered the first time.
