**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 254**-Representative Balderson.

Cosponsors: Representatives Mecklenborg, Zehringer, Huffman, Evans, Ruhl, Stebelton, Snitchler, Harwood, Pryor, Boyd.

To amend section 4141.30 of the Revised Code to allow an individual to claim unemployment benefits for a dependent who is a child in the legal custody of the individual.

**H. B. No. 255**-Representative Balderson.

Cosponsors: Representatives Gardner, Huffman, Wagner, Evans, Derickson, Zehringer, McGregor, Mecklenborg, Wachtmann, Ruhl, Stautberg, Snitchler, Domenick.

To amend sections 5747.08 and 5747.98 and to enact section 5747.67 of the Revised Code to allow a \$400 income tax credit for volunteer firefighters.

**H. B. No. 256**-Representative Gardner.

To create the Small Business Health Care Affordability Task Force.

**H. B. No. 257**-Representative Snitchler.

Cosponsors: Representatives Maag, McClain, Balderson, Combs, Jordan.

To amend sections 2907.03, 2907.06, 2929.01, 2929.13, 2929.14, 2929.22, and 2929.24 and to enact section 2941.1424 of the Revised Code to require a mandatory prison term for sexual battery, increase the penalty and require a mandatory prison term for sexual imposition, and require a mandatory prison term or jail term for unlawful sexual conduct with a minor, gross sexual imposition, importuning, and endangering children under specified

circumstances involving a minor or student victim and a person in authority with respect to the victim.

Said bills were considered the first time.
