The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Okey was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 285-Representative Bacon.

Cosponsors: Representatives Wachtmann, Derickson, Ruhl, Grossman, Boose, Jordan, Uecker, Adams, J., Maag, Mandel.

To amend sections 5739.02 and 5739.05 of the Revised Code to provide a three-day period in August and in December each year during which sales of clothing, footwear, school supplies, personal computers and computer-related items, and sporting equipment are exempt from sales and use taxes.

H. B. No. 286-Representative Fende.

Cosponsors: Representatives Letson, Harwood, Williams, B., Domenick, Yuko.

To enact section 5709.30 of the Revised Code to exempt from real property taxation home improvements greater than \$5,000 for five years.

H. B. No. 287-Representatives Burke, Sears.

Cosponsors: Representatives Adams, J., Baker, Balderson, Blair, Boose, Goodwin, Grossman, Lehner, Morgan, Snitchler, Wachtmann.

To amend section 3901.71 and to enact section 5111.0210 of the Revised Code to require the Medicaid program to cover, subject to federal approval, all health benefits established as mandated health benefits under the state's insurance laws and to preclude application of additional mandated health benefits under those laws until the Medicaid program covers the health benefits.

H. B. No. 288-Representative Harwood.

Cosponsors: Representatives Ujvagi, Phillips, Williams, B., Chandler, Domenick, Luckie.

To amend sections 715.61, 4727.01, 4727.08, 4727.09, 4727.10, 4727.11, 4727.12, 4727.99, 4728.01, 4728.06, 4728.07, 4728.08, and 4728.09 and to repeal section 4727.21 of the Revised Code to make changes in laws regulating pawnbrokers and precious metal dealers to revise item information furnished to local law enforcement agencies and, under the Precious Metal Dealer Law, specify which local law enforcement agencies are to receive item information; to restrict the type of property received or purchased; to require specified proof of identity of persons pledging, redeeming, or from whom property is purchased; to increase property retaining periods, including the period an item must be retained if there is probable cause that it is stolen property; and to modify procedures and authorized civil actions in connection with returning pledged or purchased property to its true owner.

H. B. No. 289-Representatives DeGeeter, Coley.

Cosponsors: Representatives Book, Boose, Murray, Gardner, Evans, Harris, Uecker, Harwood, Gerberry, Letson, Adams, R., Lundy, Luckie, Stebelton, Mecklenborg, Lehner, Ujvagi, Yuko, Phillips, Dodd.

To amend sections 5301.072 and 5311.191 and to enact section 5321.131 of the Revised Code to prohibit condominium associations, neighborhood associations, and landlords from restricting the display of blue star banners, gold star banners, and other service flags, and to prohibit landlords from restricting the display of the United States flag.

H. B. No. 290-Representatives Bubp, Pryor.

To amend section 3313.603 of the Revised Code to include Junior ROTC as a permitted elective within the Ohio Core curriculum and to permit schools to excuse Junior ROTC students from high school physical education.

Said bills were considered the first time.
