To enact section 3321.30 of the Revised Code to require parents of students enrolled in school districts rated continuous improvement or lower to attend a parent-teacher conference.

H. B. No. 320-Representatives Martin, Baker.

Cosponsors: Representatives Adams, J., Amstutz, Bacon, Blair, Blessing, Boose, Bulp, Chandler, Combs, Daniels, Derickson, Evans, Grossman, Hackett, Hall, Jordan, Lehner, Maag, McClain, McGregor, Mecklenborg, Morgan, Ruhl, Sears, Snitchler, Stebelton, Uecker, Wachtmann, Wagner, Zehringer.

TO ALLOW NEW INTERNET-OR COMPUTER-BASED COMMUNITY SCHOOLS TO OPEN UNDER CERTAIN CONDITIONS, TO REQUIRE THE USE OF STUDENT PERFORMANCE DATA IN EVALUATING TEACHERS AND PRINCIPALS FOR LICENSURE, AND TO QUALIFY TEACH FOR AMERICA PARTICIPANTS FOR A PROFESSIONAL EDUCATOR LICENSE.

H.B. No. 313 - Representatives Ujvagi and Winburn et al.

TO AUTHORIZE A COUNTY WITH A POPULATION GREATER THAN 100,000, OR A POPULATION BETWEEN 78,000 AND 81,000, TO ORGANIZE A COUNTY LAND REUTILIZATION CORPORATION, TO AUTHORIZE A COUNTY TREASURER OF A COUNTY WITH SUCH A CORPORATION TO UTILIZE THE ALTERNATIVE REDEMPTION PERIOD IN ACTIONS TO FORECLOSE ABANDONED LANDS, AND TO IMMUNIZE A COUNTY LAND REUTILIZATION CORPORATION FROM LIABILITY FOR BREACH OF A COMMON LAW DUTY IN CONNECTION WITH A PARCEL OF LAND.
