### INTRODUCTION OF BILLS

The following bills were introduced:

**H. B. No. 596**-Representative Dodd.

Cosponsors: Representatives Hagan, O'Farrell, Slesnick, DeGeeter, Walter, Weddington, Murray, Letson, Yuko.

To amend section 4771.20 of the Revised Code to expand the right of an institution of higher education to bring a civil action for damages caused by violations of athletic association or conference regulations.

**H. B. No. 597**-Representatives Patten, Newcomb.

Cosponsors: Representatives Foley, Letson, Lundy, Moran, Okey, Pillich, Pryor, Slesnick, Walter, Williams, S., Yuko.

To amend section 5747.113 and to enact section 3701.601 of the Revised Code to allow taxpayers to contribute a portion of their income tax refunds to the Ohio Breast and Cervical Cancer Project.

**H. B. No. 598**-Representative Dyer.

To amend sections 5747.08 and 5747.98 and to enact sections 5739.125 and 5747.85 of the Revised Code to authorize a rebate or a refundable income tax credit for payment of the state tax on the sale or use of Ohio-made goods, up to \$137.50 per good.

Said bills were considered the first time.
