The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

#### **INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 328**-Representative Williams, S. Cosponsors: Representatives Domenick, Slesnick, Ujvagi, Fende, Derickson, Pryor, Harwood, Schneider.

To amend section 5747.01 and to enact section 5747.014 of the Revised Code to authorize an income tax deduction for small business owners' reinvestment of undistributed profits in business property, employee training, or research and development.

**H. B. No. 329**-Representative Williams, S. Cosponsors: Representatives Domenick, Slesnick, Schneider.

To amend sections 122.17 and 122.171 of the Revised Code to include employees working from home as employees employed in the project for purposes of the job creation and retention credits.

#### H. B. No. 330-Representative Patten.

Cosponsors: Representatives Chandler, DeGeeter, Domenick, Evans, Fende, Foley, Garland, Harris, Letson, Okey, Phillips, Pryor, Skindell, Weddington, Williams, B., Yuko.

To amend section 5513.01 of the Revised Code to authorize the director of transportation to include school districts in purchase contracts for machinery, materials, supplies, and other articles.

#### H. B. No. 331-Representative Hagan.

Cosponsors: Representatives Yuko, Stewart, Foley, Ujvagi, Boyd, Domenick, Koziura, Skindell, Phillips, Brown, Harris, Murray.

To amend sections 5101.54, 5107.12, and 5111.013 and to enact sections 5101.87 and 5101.871 of the Revised Code to require applicants for the Children's Health Insurance Program, Medicaid, Ohio Works First, and

Supplemental Nutrition Assistance Program to provide information about their employers and to require quarterly reports identifying the employers.

#### H. B. No. 332-Representative Stewart.

Cosponsors: Representatives Skindell, Slesnick, Foley, Yuko, Letson, Hagan, Harris, Garland.

To enact sections 1751.69 and 3923.85 of the Revised Code to prohibit sickness and accident insurance policies, public employee benefit plans, and health insuring corporation policies, contracts, and agreements from limiting or excluding coverage for prescription contraceptive drugs and devices and outpatient services related to the provision of such drugs and devices.

#### H. B. No. 333-Representative Stewart.

Cosponsors: Representatives Celeste, Koziura, Harris, Foley, Yuko, Letson, Garland, Hagan, Chandler, Slesnick, Weddington, Boyd.

To enact sections 3727.60, 3727.601, and 3727.602 of the Revised Code to establish the Compassionate Assistance for Rape Emergencies Act regarding emergency services provided to victims of sexual assault.

#### H. B. No. 334-Representative Pryor.

Cosponsors: Representatives Domenick, Fende, Hagan, Murray, Williams, B., Yuko.

To amend section 2929.02 of the Revised Code to change the prison term for murder from an indefinite term of fifteen years to life to an indefinite term consisting of a minimum term of fifteen, sixteen, seventeen, eighteen, nineteen, or twenty years and a maximum term of life imprisonment.

#### H. B. No. 335-Representative Combs.

Cosponsors: Representatives Grossman, Domenick.

To amend sections 120.36, 2937.22, 2949.091, 2949.094, 2949.111, 4507.45, 4510.22, and 4511.19 of the Revised Code to require that certain fees and costs paid by parties in a municipal court that is not a county operated municipal court and that appoints counsel for indigent defendants in a manner other than that provided in section 120.33 of the Revised Code be transmitted to the treasurer of the municipal corporation and used to pay the compensation of counsel appointed to represent indigent defendants.
