**INTRODUCTION OF BILLS**

The following bill was introduced:

**H. B. No. 353**-Representatives Huffman, Letson.

Cosponsors: Representatives Boose, Morgan, Derickson, Uecker, Adams, J., Stebelton.

To amend sections 4511.76 and 4511.761 and to enact section 3327.20 of the Revised Code to authorize school districts to sell commercial advertising space on school buses.

Said bill was considered the first time.

The following joint resolution was introduced:

**H. J. R. No. 6**-Representative Evans.

Proposing to amend Section 6 of Article XV of the Constitution of the State of Ohio to require the General Assembly to allow casino facilities at locations that the General Assembly designates, to require that licenses for these casino facilities be awarded by competitive bidding by the State Lottery Commission, to generally require voter approval of the operation of a casino facility in the county or municipal corporation in which the casino facility is located, to require that a tax of sixty per cent be levied and collected by the state on all gross casino revenue received by each casino facility operator, and to require that one-half of the proceeds of this tax be used solely for the support of elementary, secondary, vocational, and special education programs as determined in appropriations made by the General Assembly and one-half of the proceeds be used solely for assistance to students at certain institutions of higher education.

Said bill was considered the first time.
