The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Lundy was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 354**-Representative Yates.

To enact section 1109.051 of the Revised Code relative to the posting of debit card transactions against a bank account.

**H. B. No. 355**-Representative Yates.

To enact section 1109.051 of the Revised Code to prohibit banks from imposing minimum balance requirements or charges for providing check cashing and bill processing services in connection with a deposit account opened by a customer for personal use.

**H. B. No. 356**-Representative Mallory.

Cosponsors: Representatives Brown, Domenick, Letson, Otterman, Yuko.

To amend section 122.12 of the Revised Code to include certain Olympic-style boxing competitions as sporting events for which state grants may be awarded to a county or municipal corporation.

**H. B. No. 357**-Representative Carney.

Cosponsors: Representatives Domenick, Lehner, Okey, Slesnick, Yuko.

To amend sections 4117.10, 4729.29, 5502.21, and 5502.41 and to enact sections 121.25, 124.394, 124.395, 3345.042, and 3701.147 of the Revised Code regarding the Intrastate Mutual Aid Compact, the authority of certain emergency medical services personnel to dispense drugs during an emergency that affects the public health, the authority of the Governor to declare the existence of a health exigency, and information and guidelines issued by the Department of Health concerning health exigencies, and to declare an emergency.

**H. B. No. 358**-Representative Ujvagi.

To amend sections 3505.23, 3509.01, 3511.04, and 3511.10 and to enact sections 3509.032, 3511.14, and 3512.01 to 3512.07 of the Revised Code to change the time by which absent voter's ballots must be ready, to authorize the Secretary of State to make emergency revisions in the armed service absent voting provisions, and to establish write-in absent voter's ballots for certain overseas voters who are unable to cast regular absent voter's ballots.

**H. B. No. 359**-Representative Luckie.

Cosponsors: Representatives Williams, B., Ujvagi, Murray, Fende, Yuko, Domenick, Brown, Williams, S., Stewart.

To amend section 2903.13 of the Revised Code to impose the same criminal penalties for assaulting a school security guard as are imposed for assaulting a school teacher.

**H. B. No. 360**-Representatives Snitchler, Morgan.

Cosponsors: Representatives Boose, Grossman, Lehner, Adams, J., Derickson, Combs, Blair, Mecklenborg, Huffman, Stebelton, Blessing, Baker, Sears, Uecker, Beck, Martin.

To amend sections 4139.03, 4139.05, 5747.08, and 5747.98 and to enact section 5747.81 of the Revised Code to grant an income tax credit eliminating tax liability for five years for individuals who obtain journeyman status and who reside in Ohio and to prohibit the Apprenticeship Council from adopting standards for apprenticeship ratios that are stricter than those requirements specified in the federal regulations governing apprenticeship programs and from discriminating against open or merit shops.

**H. B. No. 361**-Representative Murray.

Cosponsors: Representatives Foley, Huffman, Domenick, Letson, Yuko, Okey, Skindell, Oelslager, Stebelton.

To amend section 2317.421 of the Revised Code to provide that in actions for damages arising from personal injury or wrongful death evidence that certain charges and fees in a written bill or statement are not reasonable and that the provision of certain specified services are not necessary is admissible to rebut the prima-facie evidence of reasonableness and necessity and that certain evidence is not admissible to rebut the prima-facie evidence of reasonableness in those actions.

**H. B. No. 362**-Representative Chandler.

Cosponsors: Representatives Weddington, Williams, B., Yuko, Domenick, Newcomb.

To amend sections 3781.10, 3781.104, and 5302.30 of the Revised Code to require fire extinguishers and carbon monoxide detectors in residential buildings and residential units, to direct the Board of Building Standards to adopt rules that establish product and installation standards for fire extinguishers and carbon monoxide detectors, to require transferors of residential real property to disclose whether fire extinguishers and carbon monoxide detectors are installed in their property, and to prohibit a transferor of residential real property from entering into a transfer agreement unless fire extinguishers and carbon monoxide detectors are installed as the bill requires.

**H. B. No. 363**-Representatives Okey, Newcomb.

Cosponsors: Representatives Evans, Adams, J., Harwood, Yuko.

To amend sections 903.01, 903.02, 903.03, 903.04, 903.05, 903.06, 903.07, 903.08, 903.081, 903.082, 903.09, 903.10, 903.15, 903.16, 903.17, and 6111.03 of the Revised Code to revise the Concentrated Animal Feeding Facilities Law, to specify that certain provisions amended by this act do not become operative until the Administrator of the United States Environmental Protection Agency approves the National Pollutant Discharge Elimination System program submitted by the Director of Agriculture, and to declare an emergency.

**H. B. No. 364**-Representative Lundy.

Cosponsors: Representatives Hagan, Luckie, Domenick, Book, Oelslager, Letson, Gardner, Yuko, Pryor.

To amend sections 4517.52, 4517.54, 4517.55, 4517.57, and 4517.59 and to enact section 4517.541 of the Revised Code relative to the termination of franchises and prohibited acts under the Motor Vehicle Dealers Law.

Said bills were considered the first time.

The following joint resolution was introduced:

**H. J. R. No. 7**-Representative Yates.

Proposing to repeal Section 11 of Article XV of the Constitution of the State of Ohio.

Said joint resolution was considered the first time.
