INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 603-Representative Morgan.

Cosponsors: Representatives Beck, Lehner, Adams, J., Derickson.

To enact section 3314.019 of the Revised Code to permit the establishment of hybrid community schools that provide both online and classroom-based instruction.

H. B. No. 604-Representative O'Farrell.

Cosponsors: Representatives Beck, Domenick, Harris, Letson, Reece, Skindell, Slesnick, Yuko.

To amend section 4503.41 of the Revised Code to allow a veteran with a service-connected disability of less than 100 per cent to apply for disabled veteran license plates upon payment of applicable fees.

H. B. No. 605-Representative Morgan.

Cosponsors: Representatives Huffman, Sears, Lehner, Adams, J.

To amend section 5709.07 of the Revised Code to exempt from property taxation real property procured for use by a school through a for-profit lease.

H. B. No. 606-Representative Stebelton.

Cosponsors: Representatives Beck, Blessing, Bulp, Burke, Combs, Derickson, Evans, Gardner, Garrison, Grossman, Huffman, Lehner, Letson, Lundy, O'Farrell, Phillips, Reece, Uecker, Yuko, Zehringer, Adams, J.

To amend section 4503.571 of the Revised Code to permit the surviving spouse of a recipient of the Purple Heart who was issued or was eligible to be issued Purple Heart license plates to retain the Purple Heart license plates or obtain such license plates until the death or remarriage of the surviving spouse.

Said bills were considered the first time.
