### INTRODUCTION OF BILLS

The following bills were introduced:

**H. B. No. 389**-Representative Huffman.

Cosponsors: Representatives McClain, Blair, Adams, J., Derickson, Grossman, Okey, Ruhl, Adams, R., Hite, McGregor, Harris, Uecker.

To amend sections 9.37 and 5705.13 of the Revised Code to authorize counties to adopt a direct deposit payroll policy, and to authorize counties to increase the amount credited to "rainy day" reserve balance accounts to one-sixth of the expenditures made in the preceding fiscal year from the fund in which the reserve balance account is established.

**H. B. No. 390**-Representative Huffman.

Cosponsors: Representatives Domenick, Blessing, Chandler, McGregor, Stebelton.

To amend section 2915.09 of the Revised Code to eliminate the maximum rate of \$450 that applies when a charitable organization rents premises to conduct a bingo session from a person other than a charitable organization and instead to require that the rental rate for this purpose be customary, competitive, and reasonable for premises in the same geographic area.

Said bills were considered the first time.

Proposing to amend Section 2p of Article VIII of the Constitution of the State of Ohio to permit the issuance of additional general obligation bonds to fund research and development.
