To amend section 2108.31 of the Revised Code to permit persons who are sixteen to donate blood with parental consent.

## S. B. No. 58-Senator Hughes.

To enact section 2927.15 of the Revised Code to prohibit a person from collecting any bodily substance of another person without privilege to do so.
