To enact section 4509.105 of the Revised Code to require the Registrar of Motor Vehicles to contract with a third party to implement an electronic insurance verification system in Ohio.

S. B. No. 69-Senator Cates.

Cosponsor: Senator Hughes.

To amend sections 1713.55, 3332.25, 3345.85, and 3701.133 of the Revised Code to require that students living in on-campus housing at institutions of

higher education be vaccinated for meningococcal meningitis and hepatitis B or obtain a waiver.

OFFERING OF RESOLUTIONS
