**INTRODUCTION AND FIRST CONSIDERATION OF BILLS**

The following bills were introduced and considered the first time:

**S. B. No. 108**-Senator Miller, R.

Cosponsors: Senators Cafaro, Morano, Miller, D., Strahorn, Sawyer, Kearney, Wilson, Turner, Smith, Fedor, Schiavoni.

To enact section 3701.0211 of the Revised Code to create the Hemophilia Advisory Council.

**S. B. No. 109**-Senator Gibbs.

Cosponsors: Senators Schaffer, Grendell.

To enact section 5709.29 of the Revised Code to exempt from real property taxation the value of single-family residential property owned by a developer or builder until the developer or builder transfers possession or title.

**S. B. No. 110**-Senator Niehaus.

To amend sections 711.05, 711.10, 3718.01, 3718.02, 3718.03, 3718.04, 3718.05, 3718.06, 3718.09, and 6117.51 and to enact sections 3718.011, 3718.023, 3718.024, 3718.025, and 3718.041 of the Revised Code, to amend sections 711.05 and 711.10 of the Revised Code, which are scheduled to take effect on July 1, 2009, to amend Section 120.05 of Am. Sub. H.B. 119 of the 127th General Assembly, and to repeal Sections 120.01 and 120.02 of Am. Sub. H.B. 119 of the 127th General Assembly to revise the Household Sewage and Small Flow On-Site Sewage Treatment Systems Law, and to declare an emergency.
