The following bills were introduced and considered the first time:

**S. B. No. 153-Senator Patton.**

To amend sections 2915.01 and 2915.091 of the Revised Code to change the definition of "instant bingo ticket dispenser" and to authorize a charitable organization to purchase, lease, and use instant bingo ticket dispensers.

**S. B. No. 154-Senator Patton.**

To enact section 3959.20 of the Revised Code to prohibit pharmacy benefit managers that have a relationship with a retail pharmacy from using that relationship to the competitive disadvantage of other retail pharmacies.
