S. B. No. 289-Senator Buehrer.

To amend sections 4740.01, 4740.02, 4740.03, 4740.04, 4740.05, 4740.06, 4740.07, 4740.10, 4740.11, 4740.12, 4740.13, 4740.14, and 4740.16 of the Revised Code to license residential heating, ventilating, and air conditioning contractors, refrigeration contractors, electrical contractors, plumbing contractors, and hydronics contractors and to make changes to the law regulating those contractors.

S. B. No. 290-Senator Kearney.

To amend section 5747.01 of the Revised Code to allow an income tax deduction for amounts spent by teachers for instructional materials.
