BILLS FOR THIRD CONSIDERATION

Sub. S. B. No. 117 - Senators Miller, D., Coughlin.

Cosponsors: Senators Turner, Strahorn, Miller, R., Smith, Schuler, Schiavoni, Morano.

To enact section 5.2239 of the Revised Code to designate the month of May as "Multiple Chemical Sensitivity Awareness Month", having been informally passed, was taken up.

The question being, "Shall the bill, Sub. S. B. No. 117, pass?"

On the motion of Senator Niehaus, **Sub. S. B. No. 117** was informally passed and retained its place on the calendar.

INTRODUCTION AND FIRST CONSIDERATION OF BILLS

The following bills were introduced and considered the first time:

S. B. No. 313-Senator Schaffer.

Cosponsors: Senators Grendell, Seitz, Gillmor, Sawyer, Turner, Buehrer, Stewart.

To enact section 6111.60 of the Revised Code to require the Director of Environmental Protection to consider, to the extent allowable under the Federal Water Pollution Control Act, specified factors before issuing NPDES permits for sewerage systems, requiring and approving long-term control plans for wet weather discharges from sewerage systems, and enforcing provisions that Act as applied to sewerage systems.

S. B. No. 314-Senator Seitz.

Cosponsors: Senators Goodman, Fedor, Miller, R., Patton, Smith, Sawyer, Stewart.

To amend sections 2925.02, 2925.03, 2925.11, 2925.12, 2925.14, 2925.23, 2925.36, 3719.06, 3719.81, 4729.01, 4729.51, and 4732.01 and to enact sections 4732.29, 4732.291, 4732.292, 4732.293, 5120.052, and 5120.053 of the Revised Code to authorize the Director of Rehabilitation and Correction to implement a program to improve prisoners' access to psychotropic drugs and a program authorizing the provision of medical and behavioral health care to prisoners through telecommunication methods.
