### INTRODUCTION OF BILLS

The following bills were introduced:

**H. B. No. 406**-Representative Beck.

Cosponsors: Representatives Reece, Combs.

To amend section 5747.98 and to enact section 5747.78 of the Revised Code to authorize a nonrefundable income tax credit for the purchase of a new home.

**H. B. No. 407**-Representative Beck.

Cosponsors: Representatives Boose, Combs.

To enact section 5709.29 of the Revised Code to exempt from real property taxation the value of single-family residential property owned by a developer or builder until the developer or builder transfers possession or title.

**H. B. No. 408**-Representative Terhar.

Cosponsors: Representatives Grossman, Blessing, Slaby, Thompson, Stautberg, Stebelton.

To amend section 3735.27 of the Revised Code to change the composition of certain metropolitan housing authorities.

**H. B. No. 409**-Representative Peterson.

To enact section 5533.104 of the Revised Code to designate a portion of United States Route 50 within Ross County the "Lance Cpl. Aaron Reed Memorial Highway."

**H. B. No. 410**-Representatives Schuring, Slesnick.

To enact section 5533.378 of the Revised Code to designate a portion of State Route 172 in Stark County as the "U.S.M.C. Sgt. Daniel J. Patron Memorial Highway."

Said bills were considered the first time.
