The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Blair was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 23-Representative Snitchler.

Cosponsors: Representatives Slesnick, Combs, Boose, Grossman, Rosenberger, Gardner, Beck, Bubp, Stebelton, Blair, Schuring, Maag, Carey, Dovilla, Pillich.

To enact section 5533.636 of the Revised Code to designate State Route 619 within the village of Hartville in Stark County the "Sgt. 1st Class Daniel B. Crabtree Memorial Road."

H. B. No. 24-Representative Combs.

To amend sections 2950.01, 2950.11, 2950.12, and 2950.13 of the Revised Code to provide notice to a long-term care facility when a Tier III or similar category sex offender/child-victim offender indicates an intent to reside in the facility or registers an address within the specified geographical notification area including the facility.

H. B. No. 25-Representative Combs.

To amend sections 955.11, 959.99, 2152.19, 2903.213, 2903.214, 2919.26, 3113.31, 4732.141, and 4757.33 and to enact section 4731.284 of the Revised Code to revise the penalties and sentencing provisions regarding violations of the cruelty to animals statutes, to include the protection of companion animals in temporary protection orders, domestic violence protection orders, anti-stalking protection orders, and related protection orders, and to remove pit bulls from the definition of "vicious dog" in state law.

To amend sections 4301.62 and 4303.29 and to enact sections 4301.82 and 4303.235 of the Revised Code to establish local entertainment districts in municipal corporations or unincorporated areas of counties of specified populations for the purpose of the issuance of D-1, D-2, and D-5 liquor permits under specified conditions and to create the T-1 permit.

To amend section 2111.02, to enact sections 2112.01, 2112.011, 2112.02, 2112.03, 2112.04, 2112.05, 2112.21, 2112.22, 2112.23, 2112.24, 2112.25, 2112.26, 2112.27, 2112.31, 2112.32, 2112.41, 2112.42, and 2112.43, and to repeal section 2111.41 of the Revised Code to adopt the Transfer of Adult Guardianship and Protective Proceedings Jurisdiction Act.

H. B. No. 28-Representatives Stautberg, Letson.

To amend sections 2101.11 and 2151.13 of the Revised Code to eliminate personal liability for probate and juvenile judges for the default, malfeasance, or nonfeasance of any appointee or employee.

H. B. No. 29-Representative Mecklenborg.

To amend section 1901.07 of the Revised Code to increase the number of signatures required on, and to revise the process for filing, a nominating petition for election as a judge of the Hamilton County Municipal Court and to declare an emergency.

H. B. No. 30-Representative Gardner.

To amend sections 3301.07, 3301.16, 3302.05, 3302.07, 3306.01, 3306.02, 3306.05, 3306.06, 3306.07, 3306.08, 3306.09, 3306.091, 3306.10, 3313.489, 3316.031, 3316.043, 3316.08, 3321.01, 3321.05, 5705.391, and 5705.412 and to repeal sections 3306.18, 3306.25, 3306.29, 3306.291, 3306.292, 3306.30,

3306.31, 3306.33, 3306.34, 3306.35, 3306.40, 3313.821, 3313.822, and 3318.312 of the Revised Code; and to repeal Section 265.70.70 of Am. Sub. H.B. 1 of the 128th General Assembly and Section 9 of Sub. H.B. 318 of the 128th General Assembly to eliminate spending and reporting requirements related to the school funding system, to abolish the School Funding Advisory Council, to eliminate the requirement that school districts offer all-day kindergarten, to eliminate the requirement that school districts establish family and civic engagement teams, and to reduce to three years the period covered by financial forecasts of school districts, community schools, and STEM schools.

Said bills were considered the first time.
