The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Gonzales was selected to preside under the Rule.

The journal of yesterday was read and approved.

#### **INTRODUCTION OF BILLS**

The following bills were introduced:

H. B. No. 31-Representative Combs.

To enact section 5.091 of the Revised Code to adopt the children's book Lentil as the official children's book of the state and to designate its author, Robert McCloskey, as the official children's book author of the state.

# H. B. No. 32-Representative Amstutz.

Cosponsors: Representatives Burke, Carey, Slaby, Derickson, Patmon, Henne, Hackett.

To enact section 4733.011 of the Revised Code to exempt from the Professional Engineers and Surveyors Law the preparation of plans or drawings for a sewage treatment system or components of a system and measurements concerning such a system or components that are necessary to comply with the Household and Small Flow On-site Sewage Treatment Systems Law.

H. B. No. 33-Representative Snitchler.

Cosponsors: Representatives Combs, Boose, McClain, Grossman, Stebelton, Blair, Okey, Hackett, Dovilla, Kozlowski, Hollington.

To amend sections 149.43, 149.45, 319.28, and 319.54 of the Revised Code to exclude the residential and familial information of a federal law enforcement officer from the definition of a public record, to include federal law enforcement officers among the protected individuals who are authorized to request a public office other than the county auditor to redact the person's address from any record made available to the general public on the internet, and to include those officers among the protected individuals who may request the county auditor to replace the person's name with the person's initials on the general tax list and duplicate.

## H. B. No. 34-Representative Snitchler.

Cosponsors: Representatives Combs, McClain, Hackett, Kozlowski, Blair, Stautberg.

To amend sections 2907.03, 2907.06, 2929.01, 2929.13, 2929.14, 2929.22, and 2929.24 and to enact section 2941.1424 of the Revised Code to require a mandatory prison term for sexual battery, expand the offense of sexual imposition, and require a mandatory prison term or jail term for unlawful sexual conduct with a minor, gross sexual imposition, importuning, and endangering children under specified circumstances involving a victim who is a minor or student and an offender who is a person in authority with respect to the victim.

#### H. B. No. 35-Representative Sears.

Cosponsors: Representatives Blessing, Henne, Kozlowski, Pillich.

To amend section 4508.02 of the Revised Code to require the classroom and behind-the-wheel instruction that is given to minors in driver education courses to include instruction on the proper driving techniques that noncommercial motor vehicle operators should utilize in order to share the roadway with large commercial motor vehicles safely.

H. B. No. 36-Representatives Kozlowski, Carey.

Cosponsors: Representatives Boose, Burke, Dovilla, Grossman, Hayes, Johnson, McKenney, Roegner, Rosenberger, Ruhl, Slaby, Stautberg, Stebelton, Thompson, Young, Combs, Balderson, Gonzales, Martin, Baker, Hottinger, Derickson.

To amend sections 3313.482 and 3317.01 of the Revised Code to excuse up to five, instead of three, calamity days for the 2010-2011 school year, to broaden schools' authority to make up calamity days by lengthening remaining days in the school year, and to declare an emergency.
