### INTRODUCTION OF BILLS

The following bills were introduced:

## H. B. No. 37-Representative Luckie.

Cosponsor: Representative Combs.

To amend sections 2950.01, 2950.03, 2950.04, 2950.041, and 2950.05 of the Revised Code to require that a registrant under the Sex Offender Registration and Notification Law who does not have a fixed residence address provide a detailed description of the places at which the registrant intends to stay upon initial registration and, if the registrant is a Tier III registrant, a predator, or in another specified category, be monitored by an active global positioning system device until the registrant acquires a fixed residence address.

# H. B. No. 38-Representative Luckie.

Cosponsors: Representatives Murray, Weddington.

To amend section 2903.13 of the Revised Code to impose the same criminal penalties for assaulting a school security guard as are imposed for assaulting a school teacher.

# H. B. No. 39-Representative Luckie.

To amend section 3332.031 and to enact sections 3332.062, 3332.063, 3332.19, and 3332.21 of the Revised Code to make changes to laws regarding proprietary schools.

# H. B. No. 40-Representative Damschroder.

Cosponsors: Representatives Murray, Sears, Boose, Amstutz, Slaby, Blessing, Gardner, Roegner, Stebelton, Blair, Brenner, Ruhl.

To enact section 5537.051 of the Revised Code to make the Ohio Turnpike Commission responsible for major maintenance and repair and replacement of

grade separations at intersections of any turnpike project with county and township roads.

# H. B. No. 41-Representative Boose.

Cosponsors: Representatives Adams, R., Baker, Blair, Bubp, Burke, Carey, Derickson, Hackett, Henne, Huffman, McGregor, McKenney, Newbold, Pillich, Ruhl, Stebelton, Thompson, Uecker, Wachtmann.

To enact sections 101.273, 103.30, and 141.012 of the Revised Code to decrease by 5% the salaries of General Assembly members and of the statewide elected executive officers until certain increases occur in the Gross Domestic Product of Ohio.

# H. B. No. 42-Representative Boose.

Cosponsors: Representatives Beck, Blair, Blessing, Bubp, Carey, Combs, Dovilla, Gardner, O'Brien, Maag, Pillich, Slaby.

To enact section 5533.763 of the Revised Code to designate a portion of United States Route 20 in Ridgefield Township and the Village of Monroeville as the "Army Private Jason L. Sparks Memorial Highway."

# H. B. No. 43-Representatives Goyal, Williams.

Cosponsors: Representatives Driehaus, Szollosi, Pillich, Stinziano, Derickson, Reece, Boyd, Phillips, Grossman, Slesnick, Weddington, Yuko, Sykes, Heard, DeGeeter.

To amend section 150.07 of the Revised Code to increase the annual and aggregate limit on the amount of tax credits the Ohio Venture Capital Authority may authorize.

# H. B. No. 44-Representatives Goyal, Garland.

Cosponsors: Representatives Driehaus, Szollosi, Murray, Pillich, Stinziano, O'Brien, Reece, Williams, Patmon, Yuko, Lundy, Boyd, Slesnick, Phillips, Weddington, Heard.

To enact sections 166.45 to 166.51 of the Revised Code to create the Small Business Working Capital Loan Program.

Said bills were considered the first time.
