## ONE HUNDRED THIRTIETH DAY Hall of the House of Representatives, Columbus, Ohio **Tuesday, February 28, 2012, 11:00 o'clock a.m.**

The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Duffey was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

### **INTRODUCTION OF BILLS**

The following joint resolution was introduced:

H. J. R. No. 5-Representatives Celeste, Duffey.

Proposing to amend Sections 1, 2, 3, 5, 6, 7, 10, 11, 12, 13, and 15 of Article XI, to amend, for the purpose of adopting new Section numbers as indicated in parentheses, Sections 5 (4), 6 (5), 7 (6), 10 (7), 11 (8), 12 (9), 13 (10), and 15 (11) of Article XI, and to repeal Sections 4, 8, 9, and 14 of Article XI of the Constitution of the State of Ohio to revise the redistricting process for General Assembly and Congressional districts.

Said joint resolution was considered the first time.

The following bills were introduced:

**H. B. No. 463**-Representative Gerberry. Cosponsors: Representatives Garland, Murray, Boyd, Ashford, Yuko.

To amend section 101.28 of the Revised Code to require joint conventions of the General Assembly held for the purpose of hearing the Governor's annual message on the condition of the state to be held in the Hall of the House of Representatives, and to authorize the Governor to deliver that message to the General Assembly via electronic transmission.

H. B. No. 464-Representative Foley.

Cosponsors: Representatives Hagan, R., Goyal, Williams, Winburn, Antonio, Driehaus, Yuko.

To amend section 1509.19 of the Revised Code to prohibit well stimulation unless all methane gas released as a result of the proposed stimulation of the well is captured by the owner of the well or the owner's authorized representative and to revise other requirements governing well stimulation.

H. B. No. 465-Representative Foley.

Cosponsors: Representatives Yuko, Letson, Driehaus, Murray, Antonio, Ramos, Hagan, R., Williams.

To amend section 2941.47 of the Revised Code to permit the trial of a corporation in absentia in a criminal proceeding in any trial court and in such a proceeding initiated by a complaint.

**H. B. No. 466**-Representative Patmon. Cosponsor: Representative Yuko.

To enact section 3345.37 of the Revised Code to require that employees and students at state institutions of higher education who work with children receive training in child abuse prevention.

**H. B. No. 467**-Representatives Johnson, Peterson. Cosponsors: Representatives Wachtmann, Adams, J., Beck, Hayes, Patmon, Grossman, Stebelton, Conditt, Yuko.

To amend sections 3719.41, 4715.033, 4715.034, 4715.30, 4715.301, 4715.302, 4723.487, 4725.092, 4729.16, 4729.162, 4729.291, 4729.51, 4729.552, 4729.57, 4729.79, 4729.80, 4729.86, 4730.53, 4731.054, 4731.055, 4731.22, and 4731.39 of the Revised Code regarding enforcement powers of certain health care professional licensing boards, regulation of pain management clinics, limits on prescriber-furnished controlled substances, and classifications of certain controlled substances.

Said bills were considered the first time.
