The House met pursuant to adjournment.

To amend sections 3719.06, 4723.481, 4723.482, 4723.492, and 4723.50 of the Revised Code to modify the authority of certain advanced practice nurses to prescribe schedule II controlled substances.

To create "ListenFirst" panels, to repeal Sections 1, 2, and 3 of this act, and to declare an emergency.

To amend sections 4301.17, 4303.26, and 4303.292 of the Revised Code to prohibit the Division of Liquor Control from issuing a retail liquor permit or entering into an agency liquor contract if the permit location or liquor agency store is proposed to be located within one thousand feet from a school, church, library, public playground, or township park.

H. B. No. 147-Representative Weddington.

Cosponsor: Representative Derickson.

To amend sections 4506.03, 4506.12, 4506.16, and 4506.24 of the Revised Code to require the Registrar of Motor Vehicles to disqualify the holder of a commercial driver's license from operating a commercial motor vehicle upon a municipal OVI conviction and to eliminate the waiver provision for restricted commercial driver's licenses for farm-related service industries.
