The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Blair was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 205-Representative Derickson.

Cosponsors: Representatives Sears, Adams, J., Huffman.

To enact section 3314.019 of the Revised Code to permit the establishment of hybrid community schools that provide both remote technology-based and classroom-based instruction.

H. B. No. 206-Representative Stinziano.

Cosponsors: Representatives Ashford, Milkovich, O'Brien, Reece, Yuko.

To amend sections 5747.08, 5747.113, and 5747.98 and to enact sections 5502.53 and 5747.65 of the Revised Code to allow taxpayers to contribute a portion of their income tax refunds to community policing efforts and to grant a nonrefundable income tax credit for taxpayers who donate to community safety programs.

H. B. No. 207-Representatives Balderson, Letson.

Cosponsors: Representatives Huffman, Yuko, Gerberry, Landis, Thompson, Derickson, Stinziano, Fende, Ashford, Combs, Phillips, Schuring, Martin, Buchy, Hayes, Blair, Hottinger, Milkovich.

To enact section 5.2267 of the Revised Code to designate the first week of April of each year as "Ohio Coal Miners Week."

H. B. No. 208-Representatives Stinziano, Antonio.

To amend section 3313.666 of the Revised Code to require that school anti-bullying policies prohibit harassment, intimidation, or bullying that is based on any actual or perceived trait or characteristic of a student.

Said bills were considered the first time.
