### INTRODUCTION OF BILLS

To amend sections 1345.30 and 1345.99 of the Revised Code to specify individuals who are permitted to recommend and fit hearing aids and to prohibit specified sales of hearing aids via mail.

### H. B. No. 546-Representatives Slesnick, McGregor.

Cosponsors: Representatives Antonio, Brenner, Murray, Stebelton.

To amend sections 109.572, 4763.01, 4763.02, 4763.05, 4763.08, 4763.11 to 4763.15, 4763.17, and 4763.19 and to enact sections 4768.01 to 4768.15 and 4768.99 of the Revised Code to change the definition of "appraisal" for purposes of the Real Estate Appraiser Licensing Law, to make changes to the exceptions to licensure under that law, and to regulate appraisal management companies.

### H. B. No. 547-Representative Pillich.

To amend sections 5751.20 and 5751.21 of the Revised Code to modify the school district reimbursement schedule for the loss of revenue from the tangible personal property tax phase-out.

### H. B. No. 548-Representative Pillich.

RE: OHIO MILITARY MEDAL OF DISTINCTION-REVISE LAW

Representative Johnson moved to amend the title as follows:

Add the names: "Johnson, Landis, Butler, Fedor, Hagan, C., Martin, Milkovich, Rosenberger."

Representative Johnson moved to amend as follows:

In line 32, after "(C)" insert " (1)"

In line 33, delete " <u>department of veterans services</u>" and insert " <u>adjutant general</u>"

In line 34, strike through "adjutant general" and insert "  $\underline{\text{department of veterans services}}$ "

In line 36, after the underlined period insert " The medal shall be presented to the recipient's primary next of kin, as designated by the recipient. If the recipient has not designated a primary next of kin or if the designated primary next of kin is deceased, the primary next of kin shall be determined under the rules of the

United States department of defense.

In line 37, delete "The" and insert:

" (2) The"; delete " . with" and insert " and"; delete the second underlined comma; after " shall" insert " hold a joint ceremony to"

In line 38, after "year" insert " and to present each medal to the recipient's primary next of kin, as determined under division (C)(1) of this section"; after the period insert "Beginning in 2013, in any year in which the governor holds a wreath-laying ceremony to honor the deceased veterans of the state, the ceremony to recognize the medal recipients shall be held on the same day as the wreath-laying ceremony."

In line 39, after "(D)" insert "(1) If a parent of the medal recipient is the primary next of kin, as determined under division (C)(1) of this section, and the medal recipient's parents are not married to each other or are legally separated from each other, the medal recipient's other living parent may request a duplicate medal at no cost.

If neither of the medal recipient's parents is the primary next of kin, as determined under division (C)(1) of this section, the living parents of the medal recipient jointly may request a duplicate medal at no cost, except that if the parents of the medal recipient are not married to each other or are legally separated from each other, each living parent may request a duplicate medal at no cost.

If the medal recipient's spouse is not the primary next of kin, the spouse may request a duplicate medal at no cost.

The adjutant general shall prescribe a form by which a parent or spouse may request a duplicate medal under division (D) (1) of this section.

To amend section 4501.21 and to enact sections 4503.514, 4503.524, 4503.525, 4503.549, 4503.732, and 4503.90 of the Revised Code to create certain special license plates, was taken up for consideration the third time.

"Sec. 4503.533. (A) Any person who has been awarded the combat action ribbon or badge may apply to the registrar of motor vehicles for the registration of any passenger car, noncommercial motor vehicle, recreational vehicle, or other vehicle of a class approved by the registrar that the person owns or leases. The application shall be accompanied by such documentary evidence in support of the award as the registrar may require. The application may be combined with a request for a special reserved license plate under section 4503.40 or 4503.42 of the Revised Code.

Upon receipt of an application for registration of a motor vehicle under this section and the required taxes and fees, and upon presentation of the required supporting evidence of the award of the combat action ribbon or badge, the registrar shall issue to the applicant the appropriate motor vehicle registration and a set of license plates and a validation sticker, or a validation sticker alone when required by section 4503.191 of the Revised Code.

In addition to the letters and numbers ordinarily inscribed on license plates, the license plates shall be inscribed with the words "combat action ribbon" or "combat action badge" and bear a reproduction of the combat action ribbon or badge. The license plates shall bear county identification stickers that identify the county of registration by name or number.

The license plates and a validation sticker or, when applicable, a

validation sticker alone shall be issued upon payment of the regular license tax required by section 4503.04 of the Revised Code, payment of any local motor vehicle license tax levied under Chapter 4504. of the Revised Code, payment of any applicable additional fee prescribed by section 4503.40 or 4503.42 of the Revised Code, and compliance with all other applicable laws relating to the registration of motor vehicles.

(B) No person who is not a recipient of the combat action ribbon or badge shall willfully and falsely represent that the person is a recipient of the combat action ribbon or badge for the purpose of obtaining license plates under this section. No person shall own a motor vehicle bearing license plates issued under this section unless the person is eligible to be issued those license plates.

(C) Sections 4503.77 and 4503.78 of the Revised Code do not apply to license plates issued under this section."

Representatives Hagan, R. and Martin voted in the negative-2.

Having received a constitutional majority, the emergency clause stood as part of the bill.
