conviction or adjudication if the person's participation in the offense or act was a result of being a victim of human trafficking, to recommend that agencies that grant licenses for trades or professions require training related to human trafficking, to require the Division of Criminal Justice Services to create and make available a poster that provides information regarding the National Human Trafficking Resource Center hotline, to create the Victims of Human Trafficking Fund, and to declare an emergency, was taken up for consideration the third time.
