# INTRODUCTION OF BILLS

The following bill was introduced:

# H. B. No. 252-Representative Young.

Cosponsors: Representatives Henne, Maag, Newbold, Martin, Buchy, Beck, Sprague, Blessing, Ruhl, Johnson, Bubp, Combs, Roegner, Thompson, Adams, J.

To amend sections 4123.01, 5104.30, 5107.05, 5111.01, and 5115.02 and to enact sections 3801.01, 3801.02, 3801.03, and 3801.04 of the Revised Code to require a prosecuting attorney to ask the Immigration and Naturalization Service of the United States to verify or ascertain the immigration status of an offender who has been convicted of or pleaded guilty to a felony, to require a prosecuting attorney if the INS informs the prosecutor that the offender is an illegal alien to notify the alleged felon's employer, the Department of Job and Family Services, the Registrar of Motor Vehicles, and the Secretary of State, to make illegal aliens ineligible for certain state public benefits, and to prohibit the Registrar of Motor Vehicles from issuing a driver's license to an alleged felon with respect to whom a prosecuting attorney has given the Registrar the above notice and require the Registrar to cancel any driver's licenses issued to such an alleged felon.

Said bill was considered the first time.

## BILLS FOR THIRD CONSIDERATION

Sub. H. B. No. 138-Representative Gerberry.

Cosponsors: Representatives Hagan, R., Fedor, Yuko, Letson, Phillips.

To amend sections 109.73, 317.08, 959.131, 1717.01, 1717.04, 1717.06, and 1717.09 of the Revised Code to require an individual to file proof of successful completion of training with the county recorder prior to being appointed as a humane society agent and to require the revocation or suspension of an appointment under certain circumstances, was taken up for consideration the third time.

To enact sections 303.214, 519.214, 713.082, and 5502.031 of the Revised Code to codify federal restrictions on local zoning of amateur station antenna structures thereby preserving amateur radio service communications as a Homeland Security resource and to place the burden of proof for compliance on the zoning authority, was taken up for consideration the third time.

To enact section 6111.60 of the Revised Code to require the Director of Environmental Protection to consider, to the extent allowable under the Federal Water Pollution Control Act, specified factors before issuing NPDES permits for publicly owned sewerage systems, requiring and approving long-term control plans for wet weather discharges from publicly owned sewerage systems, and enforcing provisions of that Act as applied to publicly owned sewerage systems, was taken up for consideration the third time.
