INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 572-Representative Dovilla.

Cosponsors: Representatives Derickson, Kozlowski, Grossman.

To amend sections 2317.54, 5101.60, 5101.61, 5101.611, 5101.62 to 5101.64, 5101.66 to 5101.71, 5101.72, 5101.99, 5123.61, and 5126.31; to amend, for the purpose of adopting new section numbers as indicated in parentheses, sections 5101.61 (5101.63), 5101.611 (5101.64), 5101.62 (5101.65), 5101.63 (5101.652), 5101.64 (5101.66), 5101.65 (5101.68), 5101.66 (5101.681), 5101.67 (5101.682), 5101.68 (5101.69), 5101.69 (5101.70), 5101.70 (5101.71), 5101.71 (5101.61), and 5101.72 (5101.611); and to enact new sections 5101.62, 5101.67, and 5101.72 and sections 5101.631, 5101.632, 5101.651, 5101.701, 5101.702, 5101.74, and 5101.741 of the Revised Code to revise the laws governing the provision of adult protective services; and to amend the version of section 5123.61 of the Revised Code that is scheduled to take effect on October 1, 2012, to continue amendments made by this act to that section.

H. B. No. 573-Representative Schuring.

To enact sections 123.25 to 123.34 of the Revised Code to require the development and operation of state-wide data centers, to authorize the issuance of securities to fund the data centers, and to make an appropriation.
