The House met pursuant to adjournment.

**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 295**-Representative Ruhl.

To amend section 1711.09 of the Revised Code to remove the prohibition that an agricultural society must not permit, during, for one week before, or for three days after a fair, a charitable organization to conduct games of chance or bingo on the fairground.

To amend section 3333.07 and to enact section 3333.43 of the Revised Code to require the Chancellor of the Ohio Board of Regents to establish standards and protocols for approving career-technical planning districts to award associate degrees.

**H. B. No. 297**-Representatives Weddington, Fende.

Cosponsors: Representatives Hagan, R., Foley, Antonio, Murray, Driehaus, Ashford, Patmon.

To amend section 1327.99, to enact new section 1327.70 and section 319.56, and to repeal section 1327.70 of the Revised Code to require the Department of Agriculture to establish a motor fuel quality testing program under which county auditors may conduct such testing.
