To amend sections 2921.13 and 2921.22 of the Revised Code to require a parent, legal guardian, or custodian of a child under the age of sixteen to report to a law enforcement agency within twenty-four hours after the child is missing or within one hour after the parent, legal guardian, or custodian discovers that the child is deceased, to increase penalty for falsification to mislead a public official, and to specify that the above provisions are to be known as "Caylee's Law."

**Section 4.** Sections 3 and 4 of this act are hereby declared to be emergency measures necessary for the immediate preservation of the public peace, health, and safety. The reason for such necessity is to ensure that Ohio voters are not disenfranchised by a temporary change to the number of digits of the elector's Social Security Number to be included on election-related documents. Therefore, Sections 3 and 4 of this act go into immediate effect."

Mr. Speaker:

I hereby resign the office of Representative of the 94th District of the Ohio House of Representatives, upon taking the Oath of the Office as the Senator for the 20th District of the Ohio Senate.

It has been one of the great honors of my life to serve under your leadership in the Ohio House of Representatives.
