INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 300-Representatives Goyal, Ruhl.

Cosponsors: Representatives Driehaus, Murray, Phillips, Yuko, Antonio, Patmon.

To amend sections 121.40, 955.261, 2913.01, 2913.02, 2921.321, and 3701.04, to enact sections 5502.281 and 5502.282, and to repeal section 121.404 of the Revised Code to provide protections for search and rescue dogs and to make changes to the law regarding emergency volunteers.

H. B. No. 301-Representatives Hottinger, Beck.

Cosponsors: Representatives Hackett, Fende, Derickson, Williams, Wachtmann, Combs, Patmon, Blair, Szollosi, Kozlowski.

To amend section 2921.22 of the Revised Code to require a parent, legal guardian, or custodian of a child under the age of thirteen to report to a law enforcement agency within twenty-four hours after the child is missing or the parent, legal guardian, or custodian discovers that the child is deceased.
