INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 302-Representative Adams, R.

To amend section 1901.31 of the Revised Code to make the clerk of courts of Miami County the clerk of the Miami County Municipal Court and to declare an emergency.

To amend sections 2305.113, 2711.22, 3963.01, 4503.44, 4723.01, 4723.03, 4723.06, 4723.07, 4723.08, 4723.09, 4723.17, 4723.171, 4723.24, 4723.271, 4723.28, 4723.32, 4723.34, 4723.35, 4723.41, 4723.42, 4723.43, 4723.431, 4723.44, 4723.48, 4723.482, 4723.61, 4723.64, 4723.65, 4723.651, 4723.652, 4723.66, 4723.67, 4723.68, 4723.69, 4723.71, 4723.72, 4723.73, 4723.74, 4723.75, 4723.751, 4723.76, 4723.77, 4723.79, 4723.83, 4723.84, 4723.87, 4723.88, 4723.99, 5111.88, and 5120.55; to amend, for the purpose of adopting a new section number as indicated in parentheses, sections 4723.17 (4723.18) and 4723.171 (4723.181) and to enact new section 4723.17 and sections 4723.091, 4723.092, 4723.19, and 4723.653; and to repeal sections 4723.483, 4723.62, 4723.621, 4723.63, and 4723.78 of the Revised Code to revise the law governing nurses, medication aides, dialysis technicians, and certified community health workers.

H. B. No. 304-Representative Antonio.

To amend section 1505.07 of the Revised Code to ban the taking or removal of oil or natural gas from and under the bed of Lake Erie.
