The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Pelanda was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 584-Representative Foley.

Cosponsors: Representatives Hagan, R., Driehaus, Antonio, Phillips, Winburn.

To enact section 101.36 of the Revised Code to require the Governor to participate in House Question Times.

H. B. No. 585-Representative Damschroder.

Cosponsors: Representatives Blessing, Boose, Brenner, DeVitis, Foley, Garland, Grossman, Hackett, Kozlowski, Milkovich, Murray, Ruhl, Smith, Stinziano, Terhar, Thompson.

To amend sections 4506.01, 4506.11, 4506.16, 4507.01, 4507.13, and 4507.52 and to enact sections 4506.072, 4507.021, 4507.061, and 4507.511 of the Revised Code to authorize the issuance of an enhanced driver's license, enhanced commercial driver's license, and enhanced identification card to facilitate land and sea border crossings between the United States and Canada and Mexico, pursuant to an agreement with the United States Department of Homeland Security.

H. B. No. 586-Representative Murray.

To enact sections 5533.336 to 5533.339 of the Revised Code to designate memorial interchanges and a memorial pedestrian bridge in Huron County.

H. B. No. 587-Representative Murray.

To enact section 5533.182 of the Revised Code to designate a portion of State Route 101 between the municipal corporations of Castalia and Sandusky only, as the "Sfc. Charles L. Adkins Memorial Highway."

H. B. No. 588-Representative Murray.

To enact section 5533.183 of the Revised Code to designate a portion of U.S. 250, in the municipal corporation of Sandusky only, as the "Specialist Charles E. Odums II Memorial Highway."

Said bills were considered the first time.
