## INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 313-Representatives Carney, Carey.

To amend sections 5502.21 and 5502.41 and to enact section 3345.042 of the Revised Code to modify the laws governing the Intrastate Mutual Aid Compact.

# H. B. No. 314-Representative Beck.

Cosponsor: Representative Adams, J.

To amend section 4117.10 and to enact section 124.16 of the Revised Code to limit the amount by which a state employee's salary or wage may be increased.

# H. B. No. 315-Representatives Baker, Sears.

Cosponsors: Representatives Adams, R., Blair, Derickson, Gonzales, Grossman, Hagan, C., Henne, Huffman, Landis, Stebelton, Thompson.

To amend sections 3517.155 and 3517.992 of the Revised Code to increase the penalties for making a false statement in campaign materials related to nomination or election for a statewide office or office of a member of the General Assembly, or in regard to any campaign for or against a ballot question or issue, and to require the person who made the false statement to pay reasonable attorney's fees.

# H. B. No. 316-Representatives Rosenberger, Landis.

Cosponsors: Representatives Brenner, Bubp, Butler, Gerberry, Gonzales, Johnson, Letson.

To amend section 4511.53 of the Revised Code to permit motorcycle handlebars to be of any height so long as the height does not adversely affect the ability of the operator to operate the motorcycle safely.

H. B. No. 317-Representatives Young, Thompson.

Cosponsors: Representatives Martin, Roegner, Adams, J., Newbold, Buchy.

To enact section 124.395 of the Revised Code to impose a temporary hiring freeze in state government until the state workforce is reduced by ten per cent.

Said bills were considered the first time.
