BILLS FOR THIRD CONSIDERATION

H. B. No. 318-Representatives Blessing, O'Brien.

To amend sections 511.27, 1545.21, 3501.01, 3513.12, and 3513.262 of the Revised Code to eliminate March primary elections in presidential election years by requiring all primary elections to be conducted on the first Tuesday after the first Monday in May, and to declare an emergency, was taken up for consideration the third time.

The question being, "Shall the emergency clause stand as part of the bill?" The yeas and nays were taken and resulted - yeas 60, nays 32, as follows:

Representative Blessing moved to amend as follows:

In line 445, after the period delete the balance of the line

Delete lines 446 through 451 and insert "(A) Notwithstanding any provision of the Revised Code to the contrary, any person who, prior to the effective date of this act, filed a declaration of candidacy and petition, a declaration of intent to be a write-in candidate, or a nominating petition seeking nomination at the March 6, 2012, primary election shall be deemed to have filed those papers for nomination to the same office for the primary election scheduled to be held, pursuant to this act, on May 8, 2012. If the district boundaries for the office for which the candidate is seeking nomination change after those papers were filed, the candidate shall be deemed to have filed the necessary paperwork to become a candidate in the new district that comprises the largest portion of the territory of the district for which the candidate originally filed nominating papers.

- (B) Notwithstanding any provision of the Revised Code to the contrary, a person who wishes to seek nomination at the primary election scheduled to be held, under this act, on May 8, 2012, may file the appropriate declaration of candidacy and petition, declaration of intent to be a write-in candidate, or nominating petition for that election not later than ninety days prior to the day of that election, in the manner specified under Title XXXV of the Revised Code.
- (C) If a person filed a declaration of candidacy and petition, declaration of intent to be a write-in candidate, or nominating petition to become a candidate for nomination at the 2012 primary election prior to the filing deadline for that election as it existed before the effective date of Sections 1 and 2 of this act and files again to become a candidate for nomination at that election for the same office prior to the new filing deadline that will occur after those sections take effect, the person is not disqualified as a candidate under section 3513.052 of the Revised Code and, if the person otherwise qualifies as a candidate, shall be placed on the ballot for nomination for that office at that election.

For the purpose of this division, a person who filed a declaration of candidacy and petition, declaration of intent to be a write-in candidate, or nominating petition to become a candidate for nomination for the office of congressional representative at the 2012 primary election prior to the effective date of Sections 1 and 2 of this act and who files those documents for a different congressional district for the same election after that effective date shall be deemed to have filed to become a candidate for nomination to the same office. If the person otherwise qualifies to become a candidate, the person's name shall be placed on the ballot for the congressional district for which the person most recently filed nominating papers.

(D) It is the purpose of this section to ensure that persons who otherwise would be qualified candidates for the 2012 primary election, and who have properly filed the necessary paperwork to become candidates for that election, are not inadvertently disqualified due to changes in the filing deadline for that election."

In line 6 of the title, delete "and"; delete "declare an emergency" and insert "specify that individuals who have already filed nominating papers for the 2012 primary election prior to the bill's effective date shall be deemed to have filed those papers for the May 8, 2012, primary election, and to specify that a candidate who files for a district whose boundary changes after filing shall be deemed a candidate in the new district that comprises the largest portion of the territory of the district for which the candidate originally filed"

H. B. No. 319-Representative Huffman.

Cosponsor: Representative Maag.

To enact new section 3521.01 and to repeal section 3521.01 of the Revised Code to establish Congressional district boundaries for the state based on the 2010 decennial census of Ohio, was taken up for consideration the third time.

The question being, "Shall the bill pass?"

Representative Letson moved to amend as follows:

Delete lines 5 through 6939 and insert:

"**Section 1.** That sections 3521.11 and 3521.12 of the Revised Code be enacted to read as follows:

Sec. 3521.11. (A) The general assembly shall neither prepare nor accept from another a plan of redistricting the state for congressional districts that does not include or is not accompanied by a map of Ohio outlining the congressional districts and the corresponding list of census block assignments as they would be assigned by the plan.

(B) A redistricting plan and map shall be prepared by the majority caucus of each house of the general assembly not later than three weeks prior to any committee or floor vote on a congressional districting plan. The speaker of the house of representatives and the president of the senate shall announce the date on which the first committee vote on a congressional redistricting plan is intended to occur, which announcement shall be made at least five weeks prior to the date of the intended vote. Plans submitted by members of the public shall be submitted three weeks prior to the date on which the first committee vote is intended to occur.

The general assembly shall make public all plans produced and submitted three weeks before the first scheduled vote on a redistricting plan. In making the plans public, the general assembly shall display images or interactive versions of the maps in a physical location and online through the internet and shall make the data and electronic files that describe each plan available to the public electronically in a format that allows for meaningful analysis with computerized systems.

Sec. 3521.12. The committees in each house of the general assembly responsible for considering the adoption of congressional redistricting plans shall conduct four public hearings, at four different locations in the state, on the proposed plan or plans that the committee has under consideration. The public hearings shall commence not later than two weeks before the date on which the first committee vote is intended to occur. The speaker of the house of representatives and the president of the senate shall select locations for the public hearings so that one is conducted centrally in Columbus, one is conducted in the southwestern quadrant of the state, one is conducted in the northwestern quadrant of the state, and one is conducted in the eastern half of the state. The speaker of the house of representatives and the president of the senate shall select sites for the public hearings that are most convenient to the largest number of residents in the region in which a public hearing is to be conducted.

At a public hearing, any person may appear before the committee and comment orally, in writing, or orally and in writing on the plan or plans the committee has under consideration. The committee members shall receive all relevant comments. A person who desires to offer only written comment is not required actually to appear before the committee, but may do so by transmitting the written comment so that the written comment is received before the public hearings conclude.

The speaker of the house of representatives and president of the senate shall give notice of the public hearings in such a manner that the notice will be reasonably likely to inform all persons residing in the state in a timely fashion of their right to appear and comment on the plan of redistricting at one of the public hearings. The site and the date and time of each public hearing shall be stated in the notice. Instructions for accessing the plan or plans and maps through the web site of the general assembly shall be included in the notice. Instructions for transmitting written comments to the committee shall be included in the notice.

The general assembly shall publish the plan or plans that are under consideration in the house of representatives and senate journals. The map accompanying a redistricting plan shall be appended to the plan as published in the journals.

Section 2. This act is an emergency measure that is necessary for the immediate preservation of the public peace, health, and safety. Because this act requires the plan or plans of redistricting for Congress that are under consideration to be given public hearings at four different locations throughout the state, and because a redistricting plan must be established before the 2012

primary election, it is necessary that this act go into effect as soon as possible if the committees responsible for considering the redistricting plan are to have the benefit of the public hearings before enacting a redistricting plan. Therefore, this act goes into immediate effect."

Delete lines 1 through 4 of the title and insert:

"To enact sections 3521.11 and 3521.12 of the Revised Code to specify that plans of redistricting for congressional districts must include or be accompanied by a district map and corresponding list of census blocks, to specify a time by which plans must be ready, to specify that the plans must receive a public hearing at four locations throughout the state, and to declare an emergency."
