### INTRODUCTION OF BILLS

To amend sections 9.03 and 3599.40 of the Revised Code to prohibit a person from using public funds for specified purposes and to specify that a person or a political subdivision who violates the prohibition is guilty of a first degree misdemeanor.

# H. B. No. 327-Representative Gonzales.

To amend sections 122.17 and 122.171 of the Revised Code to provide for a six-year trial period in which taxpayers may receive a job creation or job retention tax credit for the employment of home-based employees and to

require the Director of Development to issue a report at the end of the six-year period.

To amend section 2923.129 of the Revised Code to modify the journalist exception to the provision that makes concealed handgun license records confidential.
