INTRODUCTION OF BILLS

The following bill was introduced:

H. B. No. 592-Representative Williams.

To amend sections 1901.31, 1907.20, 2101.121, 2151.35, 2152.71, 2301.20, 2323.23, 2503.11, and 2743.09 and to enact section 2701.21 of the Revised Code to require that every proceeding before any court of record be recorded by an audio electronic recording device and that the recording be made available immediately following the proceeding to any party to the proceeding and, except to the extent that the recording is a record to which public access is restricted by court rule or statute, to any other person, and to request the Supreme Court to amend the court rules it has adopted to include in those Rules provisions that correspond to the bill's requirements.

Said bill was considered the first time.
