The House met pursuant to adjournment.

The journal of the previous legislative day was read and approved.

**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 358**-Representative Carney.

To repeal Sections 3, 4, and 5 of Sub. H.B. 318 of the 129th General Assembly to require all candidates for nomination to office in 2012 to appear on the ballot at the June 12, 2012, primary election, to eliminate the requirement that Ohio conduct two primary elections in 2012, to eliminate the appropriation that would pay for the second primary election in 2012, and to declare an emergency.

**H. B. No. 359**-Representative Young.

To enact section 5533.961 of the Revised Code to designate a portion of State Route 84 in Lake County as the "Sgt. Mark T. Smykowski Memorial Highway."

**H. B. No. 360**-Representative Rosenberger.

Cosponsors: Representatives Butler, Murray, Grossman, Adams, J., Ruhl, Gonzales.

To amend sections 4927.03, 4927.15, 4931.40, 4931.41, 4931.44, 4931.49, 4931.50, 4931.60, 4931.61, 4931.62, 4931.63, 4931.64, 4931.65, 4931.66, 4931.67, 4931.69, and 4931.99, to enact sections 4931.611, 4931.621, and 4931.622, and to repeal section 4931.70 of the Revised Code to revise the amount and methods of collection and remittance of the wireless 9-1-1 charge for prepaid wireless services.

**H. B. No. 361**-Representative Letson.

Cosponsors: Representatives Gerberry, Hagan, R., Ramos, Yuko, Gentile.

To enact section 3109.054 of the Revised Code to require railroads to allow a conductor or engineer to exercise court-ordered parenting time without terminating employment, reducing pay, or taking other similar action against the parent.

**H. B. No. 362**-Representatives Gerberry, Lundy.

To prohibit the Ohio Turnpike Commission from increasing tolls before January 1, 2013, and to declare an emergency.

**H. B. No. 363**-Representative Duffey.

Cosponsors: Representatives Amstutz, Blessing, Terhar, Peterson, Roegner, McClain, Rosenberger, Wachtmann, Sears, Derickson, Butler, Grossman, Uecker, Baker, Henne, Hackett, Newbold, Hill, Ruhl, Stebelton, Hagan, C., Hall, Stinziano, Schuring, Stautberg, Sprague, Adams, R., Patmon, Huffman, Beck, Brenner.

To amend sections 131.43 and 131.44 of the Revised Code to increase the balance that must exist in the Budget Stabilization Fund, from 5% to 10% of the General Revenue Fund revenue, before revenue surpluses are applied to income tax reductions.

**H. B. No. 364**-Representatives Roegner, Duffey.

Cosponsors: Representatives Blessing, Hill, Stebelton, Thompson, Stautberg.

To amend section 4928.20 and to enact sections 4928.23, 4928.231, 4928.232, 4928.233, 4928.234, 4928.235, 4928.236, 4928.237, 4928.238, 4928.239, 4928.2310, 4928.2311, 4928.2312, 4928.2313, 4928.2314, 4928.2315, 4928.2316, 4928.2317, and 4928.2318 of the Revised Code to establish standards for the securitization of costs for electric distribution utilities.

**H. B. No. 365**-Representatives Beck, Dovilla.

Cosponsors: Representatives Stebelton, Blessing, Terhar, Hollington.

To amend section 5747.01 of the Revised Code to allow taxpayers who claim an enhanced federal income tax depreciation deduction to reduce the amount of the deduction the taxpayer must add-back for Ohio income tax purposes if the taxpayer increases payroll in the year the enhanced federal deduction is taken.

**H. B. No. 366**-Representative Hagan, R.

Cosponsors: Representatives Foley, Murray, Garland, Ramos, Gerberry, Letson, Ashford, Gentile, Yuko, Reece, Antonio, Carney.

To enact section 4923.30 of the Revised Code to establish requirements for contract carriers that transport railroad employees.

**H. B. No. 367**-Representative Maag.

Cosponsors: Representatives Grossman, Murray.

To amend sections 109.57, 1337.11, 2133.01, 2317.54, 3701.881, 3712.01, 3712.03, 3712.09, 3721.01, 3795.01, 3963.01, 4719.01, 4752.02, 5119.70, and 5119.71 and to enact sections 3712.031, 3712.041, 3712.051, and 3712.061 of the Revised Code regarding licensure of pediatric respite care programs.

Said bills were considered the first time.
