INTRODUCTION OF BILLS

The following bill was introduced:

H. B. No. 602-Representatives Lundy, Gerberry.

Cosponsors: Representatives Hagan, R., Ramos, Okey, Yuko, Murray, Letson, Phillips, Milkovich, Fende, O'Brien, Antonio, Foley, Clyde, Fedor.

To amend sections 718.01, 5739.02, 5747.01, and 5751.01 and to repeal sections 126.60, 126.601, 126.602, 126.603, 126.604, and 126.605 of the Revised Code to eliminate the authority of the Director of Budget and Management and the Director of Transportation in regard to Ohio Turnpike-related outsourcing contracts and to require the Ohio Turnpike Commission to hold public hearings on the issue of outsourcing the Ohio Turnpike.

Said bill was considered the first time.
