INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 376-Representatives Celeste, Garland.

To amend section 1739.05 and to enact sections 1751.68 and 3923.84 of the Revised Code to prohibit health insurers from excluding coverage for specified services for individuals diagnosed with an autism spectrum disorder.

H. B. No. 377-Representatives Duffey, Stinziano.

To amend sections 3335.02, 3335.09, 3337.01, 3339.01, 3341.02, 3343.02, 3344.01, 3350.10, 3352.01, 3356.01, 3359.01, 3361.01, 3362.01, and 3364.01 of the Revised Code to grant student members of the boards of trustees of state universities and the Northeast Ohio Medical University voting power and the authority to attend executive sessions.

H. B. No. 378-Representative Young.

Cosponsors: Representatives Adams, J., Beck, Blessing.

To enact section 109.5722 of the Revised Code to generally require the cancellation of an undocumented alien's driver's license and voter registration and the termination of any benefits the undocumented alien receives from programs administered or supervised by the Department of Job and Family Services, if the undocumented alien is arrested, identified as an undocumented alien by a federal fingerprint database, and has been issued a driver's license or provided a false or altered driver's license or another person's driver's license for identification at the time of arrest or processing.

H. B. No. 379-Representative Blessing.

To amend sections 4909.05, 4909.06, 4909.07, 4909.08, 4909.15, 4909.156, 4909.172, 4909.18, 4909.191, and 4909.42 and to enact section 4909.173 of the Revised Code to permit, for water-works and sewage disposal system companies, certain rate-calculation adjustments and a tax adjustment surcharge, to make changes regarding water and sewer infrastructure improvement surcharges, and to alter language regarding utility requirements for when rate increases may take effect in the absence of administrative action.

H. B. No. 380-Representative Blessing.

To enact sections 2307.951, 2307.952, 2307.953, and 2307.954 of the Revised Code to require claimants in asbestos tort actions to make certain disclosures pertaining to asbestos trust claims that have been submitted to asbestos trust entities for the purpose of compensating the claimant for asbestos exposure.

H. B. No. 381-Representative Slaby.

To amend section 3313.41 of the Revised Code with respect to offering school district property to state universities.

To amend sections 1337.092, 1337.12, 2101.24, 2109.21, 2111.02, 2111.12, 2111.121, 5301.071, 5747.02, 5801.10, 5804.11, 5804.12, 5808.02, 5808.14, 5808.17, 5810.09, and 5810.13; to enact new section 2107.52 and sections 1337.21 to 1337.64, 3793.31 to 3793.39, 5808.18, 5808.19, 5809.031, and 5810.14; and to repeal sections 1337.09, 1337.091, 1337.093, 1337.18. 1337.19, 1337.20, and 2107.52 of the Revised Code to adopt the Uniform Power of Attorney Act; to modify a trustee's duties with respect to life insurance policies, specify a trustee's power to distribute trust principal in further trust, provide for the titling of assets in trust form, permit some but not all of specified parties to enter into a private settlement agreement, and make other changes in the Trust Code; to modify the anti-lapse provisions regarding wills and adopt anti-lapse provisions applicable to trusts; to provide a mechanism for a probate court to order a person who suffers from alcohol and other drug abuse to undergo treatment; and to provide a procedure for the construction or modification of a trust that refers to the federal estate tax, generation-skipping transfer tax, or Ohio estate tax, was taken up for consideration the third time.
