**INTRODUCTION AND FIRST CONSIDERATION OF BILLS**

The following bill was introduced and considered the first time:

**S. B. No. 305**-Senator Hughes.

Cosponsor: Senator Patton.

To enact section 2923.241 of the Revised Code to prohibit designing, building, constructing, fabricating, modifying, or altering a vehicle to create or add a hidden compartment, knowing or having reasonable cause to believe the vehicle will be used to facilitate a crime, and to prohibit operating, possessing, or using a vehicle with a hidden compartment, knowing or having reasonable cause to believe that the vehicle has been or will be used to facilitate a crime.

**OFFERING OF RESOLUTIONS**

Senators Sawyer and LaRose offered the following joint resolution:

**S. J. R. No. 4**-Senators Sawyer, LaRose.

Proposing to amend Sections 1, 2, 3, 5, 6, 7, 10, 11, 12, 13, and 15 of Article XI, to amend, for the purpose of adopting new Section numbers as indicated in parentheses, Sections 5 (4), 6 (5), 7 (6), 10 (7), 11 (8), 12 (9), 13 (10), and 15 (11) of Article XI, and to repeal Sections 4, 8, 9, and 14 of Article XI of the Constitution of the State of Ohio to revise the redistricting process for General Assembly and Congressional districts.

The question being, "Shall the joint resolution, **S. J. R. No. 4**, be adopted?"

On the motion of Senator Widener, **S. J. R. No. 4**, was referred to the Committee on Rules and Reference.
