S. B. No. 206-Senator Schaffer.

To amend sections 122.17 and 122.171 of the Revised Code to allow taxpayers to count employees employed through a temporary or professional employment agency toward the payroll and income tax withholding requirements of the job creation and job retention tax credits.

S. B. No. 207-Senator Burke.

Cosponsors: Senators Jones, Seitz, Wagoner.

To enact section 6133.041 of the Revised Code to authorize a joint board of county commissioners to conduct proceedings regarding existing joint county ditches via teleconference or video conference.
