The Senate met pursuant to adjournment.

Pursuant to Senate Rule No. 3, the Clerk called the Senate to order.

Senator Manning was selected to preside according to the rule.

The journal of the last legislative day was read and approved.

INTRODUCTION AND FIRST CONSIDERATION OF BILLS

The following bills were introduced and considered the first time:

S. B. No. 368-Senator Schiavoni.

Cosponsors: Senators Cafaro, Gentile, Sawyer, Skindell, Smith, Turner, Brown.

To enact section 5.2283 of the Revised Code to designate the first week in October as "Nonviolence Week."

S. B. No. 369-Senator Schiavoni. Cosponsor: Senator Skindell.

To enact sections 4174.01, 4174.02, 4174.03, 4174.04, 4174.05, 4174.06, and 4174.07 of the Revised Code to require the Director of Commerce to keep a list of Ohio call centers, or facilities or operating units within a call center, that transfer or relocate to a foreign country, to prohibit call centers operating in a foreign country from receiving state funds, and to require call center employees to disclose their location to United States consumers if the call center is operating in a foreign country and transfer a consumer to a United States call center upon request.

S. B. No. 370-Senator Schiavoni. Cosponsors: Senators Lehner, Seitz, Turner.

To amend section 5709.12 of the Revised Code to specify that a nonprofit corporation, the principal purpose of which is operating a halfway house, community-based correctional facility, or other venue offering rehabilitative residential programming to criminal offenders is presumed to be a charitable institution exempt from property taxation.

S. B. No. 371-Senator Schiavoni. Cosponsors: Senators Kearney, Sawyer.

To enact section 2305.52 of the Revised Code to prohibit certain indemnity

agreements in motor vehicle carrier transportation contracts.

S. B. No. 372-Senator Brown. Cosponsors: Senators Cafaro, Gentile, Kearney, Lehner, Sawyer, Skindell, Smith, Schiavoni, Tavares, Turner.

To amend sections 3313.813, 3715.52, 3717.22, 3717.42, and 5104.051 and to enact sections 3327.18 and 3717.60 of the Revised Code to require school districts to allow alternative summer meal sponsors to use school facilities to provide food service for summer intervention services regardless of financial reasons if at least half of the students are federally eligible for free lunches, to allow the distribution and consumption of meals on a school bus, and to create a healthy food license for child day-care centers and school child programs.
