The Senate met pursuant to adjournment.

**INTRODUCTION AND FIRST CONSIDERATION OF BILLS**

The following bills were introduced and considered the first time:

**S. B. No. 217**-Senator Faber.

To amend sections 511.27, 1545.21, 3501.01, 3513.12, and 3513.262 of the Revised Code to eliminate March primary elections in presidential election years by requiring all primary elections to be conducted on the first Tuesday after the first Monday in May, and to declare an emergency.

**S. B. No. 218**-Senator Coley.

Cosponsor: Senator Seitz.

To enact sections 1121.051, 1155.181, 1163.221, and 1733.413 of the Revised Code to permit Ohio banks, savings and loan associations, savings banks, and credit unions to charge the same interest rate and other charges that out-of-state banks may charge Ohio customers.

**S. B. No. 219**-Senator Sawyer.

Cosponsors: Senators Schiavoni, Skindell, Turner, Kearney.

To amend sections 3301.0712, 3314.016, and 3314.35 and to repeal section 3314.36 of the Revised Code to eliminate the exemption for community schools serving dropouts from the requirement to permanently close for poor academic performance.

**S. B. No. 220**-Senator Sawyer.

Cosponsors: Senators Turner, Tavares, Smith, Kearney, Wagoner.

To enact section 3313.984 of the Revised Code to require a study of interdistrict open enrollment, and to amend sections 3310.01, 3310.06, 3313.64, 3313.97, 3313.974, 3313.982, 3314.07, 3315.18, 3317.03, 3318.011, 3323.143, 3326.51, 3327.05, and 3365.01 and to repeal sections 3313.98, 3313.981, 3313.983, and 3313.984 of the Revised Code effective July 1, 2015, to terminate interdistrict open enrollment on that date with the possibility of

renewal following the General Assembly's examination of the study's findings.

**S. B. No. 221**-Senator Sawyer.  
Cosponsor: Senator Skindell.

To amend section 3301.0711 of the Revised Code to make the elementary-level achievement assessments public records.
