To enact section 3717.56 of the Revised Code to require that employees of food service operations be trained in performing the Heimlich maneuver.

S. B. No. 376-Senators Schiavoni, Brown.

Cosponsor: Senator Sawyer.

To amend section 1739.05 and to enact sections 1751.621 and 3923.521 of the Revised Code to require insurance providers to cover human papillomavirus screenings and vaccines.
