# INTRODUCTION AND FIRST CONSIDERATION OF BILLS

The following bills were introduced and considered the first time:

**S. B. No. 378**-Senator Schiavoni. Cosponsor: Senator Cafaro.

To amend section 1509.021 and to enact section 1509.16 of the Revised Code to revise the required setback distance of a well from an occupied dwelling and to establish oil and brine storage tank requirements.

S. B. No. 379-Senator Skindell.

To amend sections 1509.06, 1509.10, and 1509.31 and to enact section 1509.091 of the Revised Code to revise the requirements concerning an oil and gas permit application, an oil and gas well completion record, designation of trade secret protection for chemicals used to drill or stimulate an oil and gas well, and disclosure of chemical information to a medical professional, to require an owner to report all chemicals brought to a well site, and to make other changes in the Oil and Gas Law.
