### INTRODUCTION AND FIRST CONSIDERATION OF BILLS

The following bills were introduced and considered the first time:

S. B. No. 249-Senator Tavares.

Cosponsors: Senators Skindell, Cafaro.

To amend section 4503.41 of the Revised Code to allow a veteran with a service-connected disability of less than 100 per cent to apply for disabled veteran license plates upon payment of one-half of the applicable fees.

### S. B. No. 250-Senator Tayares.

To amend sections 5743.01, 5743.51, 5743.62, and 5743.63 of the Revised Code to increase the tobacco products excise tax rate and to add dissolvable tobacco products to the kinds of products subject to the tax.

# S. B. No. 251-Senators Beagle, Sawyer.

Cosponsors: Senators Patton, Hite, Balderson, Daniels, LaRose.

To amend section 4710.01 and to enact sections 4710.20 to 4710.43 of the Revised Code to require the licensure of, and otherwise regulate, providers of debt settlement services.
