**INTRODUCTION AND FIRST CONSIDERATION OF BILLS**

The following bills were introduced and considered the first time:

**S. B. No. 387**-Senator Bacon.

Cosponsors: Senators Cafaro, Seitz.

To amend section 715.691 of the Revised Code to specify that income tax revenue generated within a joint economic development zone (JEDZ) may be used for the purposes of any party to the JEDZ agreement including contracting townships.

**S. B. No. 388**-Senator Coley.

Cosponsors: Senators Wagoner, Seitz, Bacon.

To amend sections 2333.22, 2715.21, 2735.02, and 2735.04 of the Revised Code to add to and clarify the powers of a receiver and to provide a procedure for a receiver's sale of real property.
