**REPORTS OF REFERENCE AND BILLS FOR SECOND
CONSIDERATION**

Senator Niehaus reports for the Standing Committee on Rules and Reference, recommending that the following bills and concurrent resolution, standing in order for second consideration, be referred to committee as recommended:

H. C. R. No. 56-Representative Gonzales, et al.

To recognize November 2012 as Personal Health Care Month.

To the Committee on Health, Human Services and Aging.

Am. Sub. H. B. No. 197-Representative Slesnick, et al.

To amend sections 1901.261, 1901.31, 1907.20, 1907.26, 1907.261, and 4503.39 and to enact sections 1901.44, 1905.202, 1907.25, and 2947.09 of the Revised Code to require that all moneys collected by the clerk of a municipal or county court be paid to the appropriate person, fund, or entity on or before the twentieth day of the month following the month in which they are collected; to authorize a municipal, mayor's, or county court to require community service in lieu of costs if at the time of sentencing or any time after sentencing the court finds that the offender cannot pay costs; to authorize a municipal, mayor's, or county court to allow payment of costs in installments if at the time of sentencing or at any time after sentencing the court finds that the offender will not be able to pay costs in full when due; and to ensure that after notice to the debtor and an opportunity to enter into an installment payment or community service agreement with the court neither the Registrar of Motor Vehicles nor any deputy registrar accepts any application for the registration or transfer of registration of a motor vehicle of a person who fails to pay any fine or costs imposed for offenses by a common pleas, municipal, mayor's, or county court.

H. B. No. 274-Representative Letson, et al.

To amend section 5301.057 of the Revised Code to provide that a transfer fee for purposes of a transfer fee covenant does not include any payment required pursuant to a conservation easement or agricultural easement.

Am. H. B. No. 387-Representatives Sears, Ashford, et al.

To amend section 505.60 and to enact section 307.093 of the Revised Code to authorize a board of county commissioners of any county to enter into agreements for the sale and leaseback of all or portions of county buildings, and to authorize a township to reimburse an officer or employee for out-of-pocket premiums attributable to insurance coverage provided for the immediate dependents of the officer or employee.
