INTRODUCTION OF BILLS

The following bills and joint resolution were introduced:

H. B. No. 1-Representatives Derickson, Romanchuk.

To amend sections 6301.01, 6301.02, 6301.03, 6301.04, 6301.06, 6301.07, 6301.08, 6301.09, 6301.10, and 6301.12 of the Revised Code to require a local workforce investment area to use OhioMeansJobs as the local workforce investment area's job placement system, to rename county one-stop systems, and to make other changes to Ohio's Workforce Development Law.

H. B. No. 2-Representatives Derickson, Brown.

To amend section 4141.29 of the Revised Code to require an unemployment compensation claimant to register with OhioMeansJobs to be eligible for unemployment compensation benefits and to require a claimant to contact a local one-stop office beginning with the eighth week of filing for unemployment compensation benefits.

H. B. No. 3-Representatives Sears, Kunze.

To amend sections 1751.12 and 3905.01 and to enact sections 3905.47, 3905.471, 3905.472, 3905.473, and 3905.474 of the Revised Code to specify licensing and continuing education requirements for insurance agents involved in selling, soliciting, or negotiating sickness and accident insurance through a health benefit exchange and to make changes to copayments, cost sharing, and deductibles for health insuring corporations.

H. B. No. 4-Representatives Stautberg, Blessing.

To amend sections 189.04, 189.05, 189.06, and 189.08 and to enact section 189.041 of the Revised Code to establish the Local Government Performance Measurement Grant Program.

H. B. No. 5-Representatives Grossman, Henne.

To amend sections 715.013, 718.02, 718.03, 718.051, 718.07, 718.09, 718.10, 718.11, 718.121, 718.13, 5703.059, 5703.57, 5717.011, 5717.03, 5739.12, 5739.124, 5741.122, 5747.063, 5747.064, and 5751.07, to amend, for the purpose of adopting a new section number as indicated in parentheses, section 718.04 (718.50), to enact new sections 718.01, 718.011, 718.04, 718.05, 718.06, 718.08, and 718.12 and sections 718.052, 718.18 to 718.31, 718.35 to 718.39, 718.41 to 718.44, and 718.99, and to repeal sections 718.01, 718.011, 718.041, 718.05, 718.06, 718.08, 718.12, and 718.14 of the Revised Code to revise the laws governing income taxes imposed by municipal corporations.

To amend sections 109.54, 2915.01, and 2915.02 of the Revised Code to permit the Bureau of Criminal Identification and Investigation to investigate criminal activity related to the Gambling Law, to make changes related to schemes of chance, and to require certifications related to the conduct of a sweepstakes with the use of a sweepstakes terminal device.

To revise the school safety laws.

To amend sections 2333.22, 2715.21, 2735.01, 2735.02, and 2735.04 of the Revised Code to add to and clarify the powers of a receiver and to provide a procedure for a receiver's sale of real property.

H. B. No. 10-Representative Hagan, C.

To amend sections 305.03, 319.04, 319.26, 321.37, 321.38, 321.46, 2921.44, 3314.011, and 3314.023; to enact sections 9.831, 117.411, 507.12, 507.15, 733.78, 733.81, 3313.30, 3314.50, 3326.211, 3328.16, and 3328.37; and to repeal section 319.25 of the Revised Code; to amend Section 267.50.70 of Am. Sub. H.B. 153 of the 129th General Assembly; and to amend Section 267.50.70 of Am. Sub. H.B. 153 of the 129th General Assembly for the purpose of changing its number to section 3314.51 of the Revised Code to establish education programs and continuing education requirements for the fiscal officers of townships and municipal corporations, to establish procedures for removing those fiscal officers, county treasurers, and county auditors from office, and to create fiscal accountability requirements for public schools, counties, municipal corporations, and townships.

To amend sections 4104.02 and 4104.05 of the Revised Code to eliminate the licensed operator requirement for gaseous fuel and fuel oil fired boilers that comply with certain safety and engineering standards.

To amend sections 3503.19, 3505.181, 3505.182, and 3505.183 of the Revised Code to require a provisional ballot to be remade and counted for the offices, questions, and issues for which the provisional voter was eligible to

vote, if the election official assisting that provisional voter failed to direct the provisional voter to the correct precinct, and to revise the portion of the provisional ballot affirmation required to be completed by the election official.

WHEREAS, It is a tradition of courtesy for the Ohio General Assembly to appoint a committee to wait upon the Governor; therefore be it

RESOLVED, That we, the members of the 130th General Assembly of Ohio, in adopting this resolution, authorize a joint session of the legislature to be held at the Crouse Performance Hall at the Lima Veterans Memorial Civic and Convention Center at 7 Town Square, Lima, on Tuesday, February 19, 2013, at 6:30 o'clock p.m., for the purpose of welcoming the Governor, the Honorable John Kasich, and receiving his message on the State of the State; and be it further

RESOLVED, That we, the members of the 130th General Assembly of Ohio, in adopting this resolution, call for a committee of nine on the part of the House of Representatives and eight on the part of the Senate to be appointed to wait upon the Governor; and be it further

RESOLVED, That the rules and customs of the House shall be observed

during the joint session; and be it further

RESOLVED, That the Clerk of the House of Representatives transmit duly authenticated copies of this resolution to Governor John Kasich and to the news media of Ohio.
